7. Work order of the works, against which the completion and payment certificate is being submitted.
8. Completion certificate from the employer (not below the rank of Executive Engineer), under whom the work has been executed.
9. All the relevant documents in support of proof of having building construction machineries, Tools & Plants in possession of the Tenderer.
10. Details of technical personnel under the incumbency of the Tenderer.
11. In case of partnership Firm/Registered Company, the intending Tenderers are requested to submit the copy of the DEED of partnership/Incorporation certificate AOA & MOA.
12. The intending tenderer in the same name and style should have achieved annual turnover of the year for 100% of proposed contract.
13. Completion certificate and payment certificate of at least one contract of building construction work, at least 60% in value of the proposed contract amount within the last 2 years from the date of publication of this notice. Such work executed should be in the government sector/zila parishad/panchayat samiti/public sector undertaking.
14. Current Trade license
15. Service tax registration certificate
16. Solvency certificate from banker preferably from Nationalised bank
17. Bank statement for last 3 months not older than 31.12.2012.
18. EPF registration certificate with challan.
