An Earnest Money Deposit (EMD) @ 5% of the quoted price rounded off to next hundred is required to be submitted in the form of Bank Draft in favour of "CLC Tanners Association' and payable at any nationalized bank at Kolkata." by hand, Speed Post/Registered Post addressed to The General Manager (Administration), CLC Tanners Association, Calcutta Leather Complex, CETP, Karaidanga, South 24 Parganas, West Bengal, PIN. 743502 latest by 3.00 PM on 27.08.2018. Scanned copy of EMD is to be uploaded. Tender/bid will be opened on 29.08.2018 at 4.00 PM. Tender received after the due date/time and/or not accompanied with the EMD shall not be considered at all. Tender/Auction Committee as constituted by the Department of MSME&T, Govt. of West Bengal reserves the right to reject any or all the tenders without assigning any reason whatsoever.

TERMS & CONDITIONS

1. The Bid auction/tender should be submitted on line only.
2. The material offered for disposal is on “as is where is” basis (consisting of three lots of all items).
3. Bidder must provide the following information along with the Financial Bid:
 - a) Capability to buy and take away such bulk stores as mentioned in Annexure II within a short period (Max. 10 days). A copy confirming the terms of supply may be included.
 - b) Income Tax, GST and other statutory clearances.
 - c) List of reputed Organizations/Institutions, where similar orders have been executed.
 - d) Xerox copy of PAN card.
 - e) Trade license issued by competent authority.
 - f) Scanned copy of EMD to be uploaded along with bid
4. The concerned authority reserves the right to verify information submitted and inspect if required, to confirm their capabilities.
5. The concerned authority reserves the right to change the quantity (upward/downward) to be tendered and vendor must have the ability to adhere to the same, if any, within the validity of the bid period.
6. Decision of the Tender Committee as constituted by the Department of MSME&T, Govt. of West Bengal on any matter regarding short listing of vendors shall be final. No Bid/enquiry on telephone will be entertained.
7. The purchaser may inspect the materials on any working day between 11.00 AM to 4.00 PM before the last date for submission of quotation by prior appointment with The General Manager (Administration), CLC Tanners Association, Calcutta Leather Complex, CETP, Karaidanga, South 24 Parganas, West Bengal, PIN. 743502, **Contact No. 9007515958** to satisfy themselves about the quality & condition of the materials offered. No complaint whatsoever will be entertained after the tenders are submitted or before or after the materials are lifted. No request for samples or inspection after submission of the tender will be accepted.
8. Bidders should clearly quote their rates both in figures and in words.
9. **Opening of the Tender**

The offer/bid will be opened by a Committee as would be constituted by the Department of MSME&T, Govt. of West Bengal for the purpose at the pre-defined place, time and date. In the event of the following, the Bids will summarily be rejected.

- a) EMD is found invalid and unacceptable;

On verifying the EMD, the price Bids will be verified. The Committee will examine the Bids and decide the suitability as per the fulfillment of qualification criteria.

10. Qualification Criteria

- a. The participant bidder should have completed the works of similar nature.
 - b. The tender will be awarded to the highest bidder. However, the competent authority is not bound to accept the highest bidder and may reject without giving reasons there for.
 - c. In case of dispute, the matter shall be settled mutually, failing which the decision of the Directorate of MSME, Govt. of West Bengal shall be final and binding
11. The balance money less the EMD already deposited should be paid within 7 days from the date of issue of offer letter. The Draft of balance amount in favour of "CLC Tanners Association" and payable at any nationalized bank at Kolkata." will be presented to the The General Manager (Administration), CLC Tanners Association, Calcutta Leather Complex, CETP, Karaidanga, South 24 Parganas, for delivery/lifting of the goods within the stipulated time of 7 days and the material will be lifted within 10 days from the date of issue of final award letter. In case the store is not lifted within the time specified ground rent as decided by the committee will be charged from the purchaser for a further period of 7 days. The materials not so removed will be treated as abandoned lots and the EMD and other sums paid for the lot will be forfeited without any reference to the purchaser. For such abandoned lots, the Directorate reserves the right to re-sell.
12. The earnest money of unsuccessful bidders will be returned to them without any interest within thirty (30) days after awarding the contract and completion of disposal of scraps and on receipt of written request from the bidders.

Forfeiture of EMD

13. After receiving the award letter, if the bidder is unable to execute it satisfactorily, the EMD will be forfeited. The scanned copy EMD is to be submitted with the Bid. Bid without EMD shall be disqualified and summarily rejected.
14. The materials will be allowed to be lifted between 11.00 AM to 5.00 PM on any working day. No picking, choosing or sorting will be allowed in the premises for the disposal lots. Proper cleaning of the area should be done by the purchaser after lifting the material.
15. Mis-description or error in quantity will not invalidate a sale.
16. The person authorized by the purchaser will be allowed to take delivery.
17. Number of vehicle to lift the material should be intimated at least one day in advance to the General Manager (Administration), CLC Tanners Association, Calcutta Leather Complex, CETP, Karaidanga, South 24 Parganas.

Special Conditions:

The purchaser shall at his own cost arrange for necessary licenses/permissions/clearances, etc. required to carry away the material from the site within the stipulated period.

18. The Tender Committee has the right of withdrawing from the sale of any material or lots at any stage without assigning any reasons there of.
19. The address given in the tender shall be deemed to be the Purchaser's address and correspondence sent on that address shall be considered to have been delivered to the

purchaser. No claim will be entertained for the reason of forfeiture of the sum deposited in case the correspondence is returned undelivered.

Completion Period


20. The successful bidder is to submit the demand draft with the quoted amount to the General Manager (Administration), CLC Tanners Association, Calcutta Leather Complex within seven days from the date of issue of offer letter to purchase the stores as per tender documents. The store is to be disposed off from the site by the said bidder within 10 days from the date of issue of the final award letter.
21. **Price:** Should be in Indian Rupees only.
22. **Freight & Insurance:** No freight and insurance charges will be provided. The materials "as is where is" are to be carried away from the site at the cost and risk of the vendor.
23. **Failure of Order Execution:** If a successful bidder after receiving the order fails to execute the order within the stipulated period or does not fulfill any of the terms and conditions in any respect, the concerned authority reserves the right to cancel the order unilaterally and assign the order to the next eligible bidder.

Payment terms

24. The successful bidder is to submit the demand draft with the quoted amount or as finalized by the concerned authority to The General Manager (Administration), CLC Tanners Association, Calcutta Leather Complex within seven days from the date of issue of offer letter to purchase the stores as per tender documents.

Disputes and Jurisdiction

25. Any legal disputes arising out of any breach of contract pertaining to the whole process of this Tender shall be settled in the Court of Competent Jurisdiction in the District of South 24-Parganas in the State of West Bengal.
